The monthly parking permit is issued and assigned to a specific individual and entitles the holder to occupy one (1) parking stall only. Anyone abusing this privilege will be subject to immediate termination. No refund for unused days will be granted. 2. Monthly parking permits are issued on a month-to-month basis and are not guaranteed to be renewable. A monthly parking permit does not reserve or guarantee the availability of a parking space. Spaces are available on a first come, first serve available space basis. 3. Payment for monthly parking permit must be received no later than seven (7) days before the first of each month. Monthly fees will not be prorated. 4. Current monthly permits must be clearly displayed on the vehicle's dashboard at all times while parked on the lot, or you may be subject to parking violation. 5. Monthly parking customers who do not have their monthly parking permit on entry will be required to pay the posted meter rate. 6. Vehicles may not be parked on the lot in excess of seventy-two (72) hours without express approval of the Department of Transportation or its authorized agent. 7. In case of loss or damage to the permit, a full monthly cost will be charged for a replacement. 8. Monthly parking permits is limited to 10-Hour parking spaces only, if applicable.
